That's right, it's a two-day event this year, with the first day devoted to professional development workshops and our usual meeting activities taking place on the second day. We are still working out the details, but the following workshops will be offered:

The Beginner IPEDS workshop will be offered Thursday morning and the Intermediate Level will be in the afternoon so that it will be possible to do both. The HEI and Focus Group workshops will be offered concurrently with the IPEDS workshops, though in which order is one of those details still to be worked out.

Fall Conference Keynote Speaker

The OAIRP Executive Committee is delighted to announce that our Keynote Speaker for the Fall 2005 Conference will be Dr. Mary Sapp. Dr. Sapp is Assistant Vice President of Planning and Institutional Research at the University of Miami in Coral Gables, Florida, and has been involved with institutional research and planning at the University since 1984. While president of the Association for Institutional Research (AIR), she initiated the AIR Alert series. She has also served as president of the Southern Association for Institutional Research (SAIR) and as chair of the Board of Directors of the Higher Education Data Sharing Consortium (HEDS).

Dr. Sapp was a member of one of last fall's Technical Review Panels for the IPEDS Student Unit Record Feasibility Study and several years ago chaired the IPEDS Student Survey Working Group. In addition, she is currently a member of AIR's Higher Education Data Policy Committee and has chaired or served as a member of several working groups of both the National Postsecondary Education Cooperative and the National Center for Education Statistics. She has also been a member of various committees of AIR, SAIR, HEDS, NACUBO, and CAUSE.

Dr. Sapp received Outstanding Service Awards from AIR and SAIR. She holds a Ph.D. in Quantitative Psychology from the University of North Carolina, Chapel Hill.

Please forward the following information to Robert Callaway (rcallawa@lorainccc.edu) on or before September 1 if you are interested in submitting a paper:

- ◆ name of the project
- ◆ contact person and information (telephone, email)
- ◆ summary of project with emphasis on research aspect (250 words or less)
- ◆ impact on the IR Profession
- ◆ any additional information

Proposals will be reviewed by the OAIRP Executive Committee, and the most outstanding will be selected for presentation at the OAIRP Fall Conference. You will need to submit your complete paper two weeks after your presentation on October 21, 2005 if your proposal is accepted by the OAIRP Executive Committee. Papers presented at the 2005 Spring and Fall Conferences may be considered for the OAIRP Best Paper, with the winner to present his or her paper at the AIR Forum in New Orleans.

The Focus Group Method and Its Application in Institutional Research

This workshop will be presented by Margie Bennett, Ph.D., of Mount Vernon Nazarene University at the Fall 2005 OAIRP Conference. It is intended for institutional researchers who conduct survey research to address various issues on their campuses and who would like to learn how to follow-up or “drill down” on certain questions via the focus group technique. The workshop introduces focus group as a powerful tool to supplement and/or enhance quantitative research designs. The presenter will explore the techniques, uses, strengths, and limitations of the focus group method. “What Focus Groups Can and Cannot Do,” The three stages of “How to Conduct Focus Groups,” Sample invitation letters and questions, and a list of references are helpful handouts that will be provided during the workshop. The power point presentation and handouts are based upon the AIR pre-conference workshop materials of Dr. David Cheng, Columbia University, 2005 AIR Conference San Diego, CA, and are being used with his permission.

Call for FALL OAIRP PRAGMATIC PRESENTATIONS

Pragmatic presentations should be about half an hour in length, enabling a fellow OAIRP member to take the idea back to his or her institution for implementation. The presentation should provide sufficient information to replicate the idea in another IR office, and preferably, should demonstrate a real-world application of the idea.

Categories of interest include, but are not limited to, the following categories:

- New Tools- software or hardware that helps you address some aspect of IR more readily or with greater accuracy or utility.
- Data management techniques that have been effective (collecting, scrubbing and/or warehousing).
- Data base queries and applications that advance your work.
- Analytical methodology –appropriate applications and ways to overcome pitfalls
- Data Reporting formats that have proved useful.
- Accountability systems that support institutional goals and coincide with accreditation needs, as well as state or federal reporting requirements.
- Research strategies or designs that advance your institutional goals.
- Strategic planning designs or activities incorporating assessment data to close the data-based decision-making loop.
- IR and Planning Office management and evaluation

Proposals for the Fall meeting should be submitted electronically by September 1, 2005 to Kathleen Fenton @ fenton.k@RhodesState.edu. Proposals should include:

- ◆ presenter contact information
- ◆ presentation title
- ◆ brief description
- ◆ key topic words
- ◆ target audience
- ◆ intended outcome(s) for the presentation.

Feedback Survey Analysis: The Spring 2005 Meeting of the Ohio Association for Institutional Research and Planning

Summary of results:

✦ Overall, the thirty-one respondents reported substantial satisfaction with the arrangements of the conference, including geography, convenience, and amenities.

✦ “Ample time for the council meetings” was the one area identified as needing improvement. This is also reflected in the respondents’ comments.

Our tradition (which means we did it this way once before) is to provide an informal summary of the survey responses rather than a full-blown analysis. Below are summary statistics (mean and standard deviation). The scale was 1-7, with 1 equivalent to very strongly agree and 7 equivalent to very strongly disagree. Respondent comments follow the chart.

The food provided was good	30	1.1	.35
There was ample opportunity to network with others	31	1.7	.89
There was ample time for the council meetings	30	4.0	1.6
The scheduling of the conference was well organized	31	1.9	.91

I like the format where members were asked to present a short (30 min) presentation on new or time saving ideas that they have created or found. The only VERY minor complaint that I have is when the registration list was sent out via email, there was a column that was listed as “dues”, but it was unclear whether it was dues paid or dues owed. Please add a modifier to the dues column.

It was an exceptionally well-run facility & while the food has always been good-this was above the usual. I wouldn’t mind returning.

I love having the conferences at Miami.

Conference was very good and the topics were very helpful. I don’t remember having a council meeting, though. My only comment was the meeting ending as late as it did made for a long late drive for those of us in the North East.

Allow time for Council meetings.

I suggest that people should submit two support letters from colleagues or a reference letter attesting to the academic quality of their presentation contents as part of the submission process. Others may have an idea about how to vet proposals to ensure quality.

Time should have been set aside for the council meetings. There was little time last fall and no time this spring.

While the geographic location of the conference was not very convenient, I enjoyed seeing the Miami campus and would continue to encourage OAIRP to rotate the spring conferences to willing campuses throughout the state.

A longer conference (2 or 3 days) would allow for more networking and provide a greater opportunity to spend more time on subjects of interest. A larger number of areas could be addressed as well.
